The RCNM Carting Test ACKNOWLEDGEMENT and WAIVER

I (we) acknowledge that the “Rules Applying to Registration and Dog Shows” and have been made available to me (us), and that I (we) are familiar with their contents. I (we) agree that the Rottweiler Club of New Mexico (the Club) has the right to refuse entry for any cause which the Club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of the Tests for which it is intended, I (we) agree to hold the Club, it’s members, directors, officers, agents, and the owner or lessor of the premises and any of the employees of the aforementioned parties, harmless from any claim or loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the event premises or grounds or near any entrance thereto, and I (we) further agree to hold the aforementioned parties harmless from any claim for damage or injury to the dog, whether such loss, disappearance, theft, or injury , be caused or alleged to be caused by the negligence of the Club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself, ourselves, or on account of damage to property , arising out of or in consequence of my (our) participation in this event, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused negligence of the aforementioned parties or any of their employees or agents, or any other persons.

I (we) acknowledge the ARC “American Carting Test Regulations” have been made available to me (us), that I am (we are) familiar with their contents and that I (we) agree to abide by these regulations at this ARC Carting Test. I (we) understand that I (we) enter a dog(s) at this ARC Carting Test at my (our) own risk.

The City of Albuquerque, NM requires that all dogs be leashed or otherwise controlled or confined (CI and CX single and team are allowed to work off leash as required). I (we) understand this requirement and agree to abide by all the City of Albuquerque in the County of Bernalillo rules and regulations that may apply. I (we) further agree that I (we) will pick up after my (our) dog(s), failure of which will result in being asked to leave the premises and face additional charges or fines which may apply by City or County Ordinance.

I certify that I am voluntarily entering these Tests and understand that I am taking various risks, including but not limited to exposure to possible illnesses such as COVID-19. I understand that I do so entirely at my own risk and take full responsibility for my own health and safety at these Tests. I understand and acknowledge that the Rottweiler Club of New Mexico and ARC are in no way liable for any present or future illness or infection incurred at any time by any person, in attendance or not in attendance, during or after these Carting Tests.
